### LARKSPUR HISTORICAL SOCIETY PERFORMANCE HIGHLIGHTS FOR YEAR 2020

On March 5, 2020, Colorado experienced its first case of the novel COVID-19 virus. This case started the pandemic lockdowns and mandated protection guidelines in Colorado that significantly altered 2020 and, for historical societies and museum, essentially stopped most activity other than various *virtual*, occasional on-line historical get togethers. According to the Colorado Department of Public Health and Environment, as of March 6, 2021, Colorado had experienced 435,762 COVID cases impacting its 64 counties with a total related 23,886 hospitalizations and 5,995 deaths. During this same time-period, Douglas County experienced 21,897 cases and 225 deaths attributed to the virus. This brief President's Annual Report provides what was accomplished and postponed by the Larkspur Historical Society in 2020, the year of the COVID-19 worldwide pandemic.
